Subject: Provisional affiliation w.e.f. 1.5.1977 to the School
- Grant thereof.

Dear Sir,

With reference to your application, I am to convey sanction for provisional affiliation of the abovesaid school under the All-India Secondary School Course (classes IX & X) under 10+2 pattern of education w.e.f. 1.5.77 to 30.4.79, according to the syllabus/courses prescribed by the Board under this scheme.

The names of languages and that of work-experience proposed to be started as per scheme of studies may however please be intimated to the Board, so as to enable this office to issue you necessary sanction.

The sanction is subject to the fulfilment of the following conditions or that may be laid down by the Board from time to time.

1. Admission to school shall be open to all without discrimination of caste and creed and the school shall not impart education which is against the national interest.
2. The school shall observe Inter School Rules in the matter of admissions and transfers of children from one member-school to another.
3. There shall not be any raise in the tuition fee or other charges without obtaining prior approval of the Board. No special funds/levies shall be allowed to be charged.
4. It will help the Board in the smooth conduct of the examinations by placing the necessary accommodation i.e. Halls/Rooms available in holding its examinations free of charge.
5. It will provide necessary furniture i.e. desks etc. for seating the candidates appearing at the examinations of the Board free of charge; and
6. It will spare sufficient teachers for invigilation purposes at the examinations of the Board. At least one teacher may be spared for every 12 candidates appearing from the school.

With reference to your letter dated 16.5.1977 on the subject cited above, your attention is invited to the following points-

1. An approved plan of the building being constructed alongwith details of accommodations may please be furnished.
